The Healthy Start Coalition oversees several programs that provide assistance to pregnant women, families, and infants in Sarasota County, ensuring they receive needed care and services. From getting healthy before pregnancy to parenting classes, smoking cessation to psychosocial counseling, Healthy Start provides a variety of free, high-quality services to ensure that every baby has the opportunity for a healthy start in life.

A background in Human Development and Family Studies, Shon has worked supporting families for almost 20 years. Demonstrating her dynamic energy, she brings a new vitality to the organization, encouraging others to donate their time, money, and resources to help our most vulnerable community members. Honored for her work with the Save My Life Program, she was awarded one of the 2015 Unity Awards by Biz(941) and LaGuia Magazines. The Save My Life Program strives to reduce birth and health disparities in our Newtown community, providing free prenatal and postpartum support for African-American families. 
